5.	ELEVATE LEVEL SHALL BE OBTAINED FROM THE OFFICE OF CHIEF ARCHITECT CHD. ADMN. IS EXCEPT BY WORK SHALL MEANS A FACE-TO-FACE WORK WITHOUT ANY POINTING, COLOUR WASH EXCEPT DEEP FACED FINISHING AS SHOWN AT 'C'.	
6.	IF THE PUBLIC CORRIDOR FINISHED AS IN THE DRG. SHALL BE LEFT UNRESTRICTED, UNHINDERED OR UNDISCHARGED FOR THE EXCLUSIVE USE AS A PUBLIC PASSAGE.	
7.	NO POSITION OF THE BUILDING TANK OR ANY OTHER FEATURE SHALL PROJECT BEYOND THE SKY LINE. AT THE TOP OF THE PROPOSED SECURITY OTHER PIPE SHALL BE PERMITTED ON THE EXTERNAL FACADE OF THE BUILDING. ALL SUCH PIPES IN THE BUILDING SHALL PROPERLY BE FORMED.	
8.	IF THE PARTY WALL SHALL BE PROPERLY CONSTRUCTED WITH 1ST CLASS BRICK IN 1/4 CEMENT SAND MORTAR IN RECS AND SHALL HAVE ADEQUATE FOUNDATION TO THE SATISFACTION OF THE CHIEF ADMINISTRATOR.	
9.	EXTERNAL DOOR, WENTS AND ROLLING STEEL SHUTTER SHALL BE PAINTED IN GREY COLOUR OF 50 GRAMS PER SQ. METRE.
